

WITH " DEVOTION " AS INPUT
LET US CONTINUE GITHA JYOTHI ...

Our special Mangalasanams to all those who are conducting and supporting Githa Jyothi programme. 55 Dharmakshethras were completed. This programme is being conducted in other 55 places too, bringing great inspiration in the society. We firmly believe that Lord has made you all, His instruments, in rendering this wonderful social service activity. This has to be carried forward in the same manner ...

In the beginning, we have asked TTD to take up this project, along with its Dharma Prachara Parishath organisers, by arranging vehicles in all the districts of Andhra Pradesh, to go into villages and educate the masses by giving them pamphlets, books, photos, Venkateswara coins etc. TTD has to arrange vehicles in 23 districts, arrange its organisers to take up the activity for which it needs Rs.2,74,04,000/- After one year these vehicles will be with them. The printing material and coins etc., for distribution requires Rs.3,20,00,000/- . Our Vikasatarangini volunteers work along with their organisers in going from village to village, educate masses and distribute the material. This is a programme for one year. TTD somehow was not positive towards the project proposal and on 2-3-02, they declared that they are prepared to provide 2 crores for material and asked us to provide the details.

If we prepare the material and if there are no vehicles, it becomes highly impossible to go to each of the villages and distribute the material within one year. Also, nagging by departmental officers and pacifying them becomes a big exercise. Hence, we have started the project with Vikasatarangini without TTD's involvement. Because of your wonderful co-operation the project is going on well.

After 2 years, with the interest taken by the Commissioner, Dept. of Endowments, Government has taken a decision. As the propagation work ie., 'Dharma Pracharam' is already in progress, Govt. issued a G.O to TTD to issue 2.5 crores for the material to be distributed in the villages. Before that G.O copy reached us...and also before TTD board took any decision in this regard, meanwhile, due to the proactive interest of the internal staff, the message reached many other Swamis. The message reached them negatively that we are taking lots of amounts from TTD and they all started to crave for double the amount and so on through the news papers and TVs.

Taking this chance, someone went to court questioning the grants issued to Vikasatarangini, against TTD and Government. Court took the petition and said that it shall pursue. This has been deliberately 'mispropagated' and misrepresented by some newspapers and media as 'Court issued Stay against grants'. This is the contribution of purely biased 'illegal' legal correspondent to the News papers. However, papers published this wrong News.

On April 3rd Chief Justice Sri Devendar Gupta issued court order saying that "TTD may spend its money without violating the rules of the act. It can spend its money for printing material etc., for propagating Dharma. As TTD can take appropriate decision whether it is for the purpose or not, court has to do nothing with it and saying so the court dismissed the petition. This is a verdict against the petitioner. This means that TTD is given green signal to the grant of funds... Right !! During the time when Judgement was read out by the honourable Chief Justice, the illegal 'Legal' Correspondent was not present. He came at the end. The judgement order was left unsigned as the Chief Justice has to go on leave. It was left pending until 16th April. The copy of the judgement came out only



on 19th April.

Without observing any of these, the petitioners have again mispropagated with the help of the "illegal" correspondent and published in the papers on 4th April itself that there are "NO funds to Chinna Jeeyar" etc. as if they were the judging authorities. This deliberate illegal act is actually "dishonouring" the Court judgement and the Chief Justice which also misled masses, hurting the sentiments of millions of people. With the intolerable jealousy and wickedness the 'other' parties have tried to defame us and our noble programme.

When those who claim themselves as 'Swami' s opened their mouths, TTD should have explained that " Vikasatarangini asked not the money but, the printed matter, photos, coins etc.. only and that too for use in propagating Dharma " then, all these problems might not have sprouted up.

Atleast even when case was filed against TTD and Govt., none of them responded nor submitted any single paper, stating the facts. It clearly shows that they too are committed to act against us. Then you might question ' what are you doing ?'

In fact, when the things are not positive from TTD, we forgot about the involvement of TTD in the project and also release of the 2 crores 2 years back and started doing the programme with grand success with the help of all of you. When the new Commissioner said that as your programme is already on, you take the grant and use it for the purpose as proposed earlier for the material, we said 'yes'. After that, that G.O didn't reach us. Hence we remained silent about it. Neither TTD resolution, nor their proposal reached us, so we didn't speak anything about it.

We don't know how the information was conveyed to all the other Swamis. Who played the active role in creating this sort of mispropaganda against us ? It is the miscreation of the staff and the authorities, who are living with the salt of that Dharma, responsible to "Protect Dharma"... So unfortunate is the situation. We don't know... due to the support of which background forces they tried to defame us !

Many of our wellwishers suggested us to reject the TTD Fund. That is true ! But, how can we say anything without any proper document in our hands, that we want or not !

Meanwhile, case was filed. If we reject, they say that we rejected because we are afraid of the case. So we had to wait till the judgement reached our hands. "We can't speak something just like that, though others are doing so deliberately ! "

Now as per G.O , TTD has to give grants to Vikasatarangini for the material. This is a lesson for those who filed case against us. When the whole issue is burning, it is verily evident that TTD authorities themselves wanted to make us baits.

With devotees as the Divine instruments, your interest and devotion as the fuel, Social Welfare and Protecting Dharma as our goals our GITHA JYOTHI is going ahead. Till now it went on gloriously with roaring success, even though wicked and evil forces are trying to show their influence. This will continue... with criticisms as its ornaments and opposing evils as its victims. Vikasatarangini is rejecting the "material" co-operation of TTD to Githa Jyothi. Though the offering from Srinivasa is a blessing, due to the temporary imbalance in the legality of the authorities, we took this decision.

Let us continue the mission, uninterruptedly, at the pace that reaches every common man, the message of Lord Srinivasa, at the earliest. Let us pray Lord to give us all the opportunity to be more resourceful in accomplishing the final goal of the movement !!

Let us serve all beings as service to God. Let us adopt the principle of "Worship your own, respect all".
